discretion decide, do hereby:-

- 1.1 Certify that all the information contained in these forms is true and correct and that no material information whatsoever has been withheld;
- 1.2 Undertake on my own behalf and on behalf of the Participant to abide by all the rules, regulations and procedures of the Centre, with which rules regulations and procedures I acknowledge myself to be acquainted;
- 1.3 Undertake to pay all amounts payable in connection with the Participant's enrolment in the Centre.
- 2.1 Irrevocably indemnify, on my own behalf and on behalf of the Participant, the Centre Organisers (including all the Centre staff who may be teachers at Craighall Primary School or elsewhere who are to be employed at the Centre in a part-time capacity), as well as Craighall Primary School (including its staff), the Gauteng Department of Education or any person acting on their behalf, or any of its affiliated or constituent bodies and directorates and/or any representative, employee, servant or agent of any of the a foregoing bodies or persons, against any claim whatsoever which may be made against them or any of them and/or liability which may be incurred by them and/or any damage which may be suffered by them.

- 2.2 Undertake, on my behalf and on behalf of the Participant, jointly and severally, that such claim and/or liability will be paid by me and/or the Participant to the Centre Organisers or any of the bodies/persons called upon to make payment.
- 3.1 Acting on my own behalf and on behalf of the Participant, jointly and severally, absolve the Centre Organisers from any liability whatsoever and howsoever caused for any loss, injury, or damage which may be caused to the person or property of the Participant and agree that neither I nor the Participant shall have any claim of any nature whatsoever against the Centre Organisers or any of bodies (referred to herein) in such event;
- 3.2 Acting on my own behalf and on behalf of the Participant, waive all or any claims that I or the Participant may have against the Centre Organisers or any of the said bodies in respect of any loss, damage or injury to the person or property of the Participant which may be sustained by the Participant during the conveyance of the Participant by whatever mode of transport.
4. Acting on my behalf and on behalf of the participant, jointly and severally, designate the Centre Director or anyone appointed by the Centre Director to act in *loco parentis* on my behalf during the course of conducting the Centre; in particular but without derogating from the generality of the a foregoing, the Centre Director of the appointee of the Centre Director shall in his/her sole discretion have the authority to give permission for any emergency operation or medical treatment for the Participant and to incur on my behalf all expenses flowing therefrom, which I undertake to repay on demand.
5. Accept on behalf of the Participant that, in the event of the Participant being unable for any reason whatsoever to attend or participate in the Centre for the full period or at all, neither the Participant nor I shall have any claim for refund of any fees already paid to the Centre;
6. Acknowledge, on my behalf and on behalf of the Participant, that each of the afore going provisions is separable from the other of them and may be enforced against us or either of us, as the case may be separate from the other provisions.
